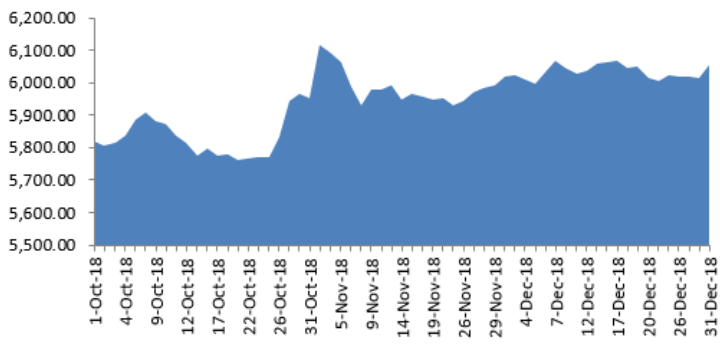

Movement in ASPI - by Sector 2018:Q4

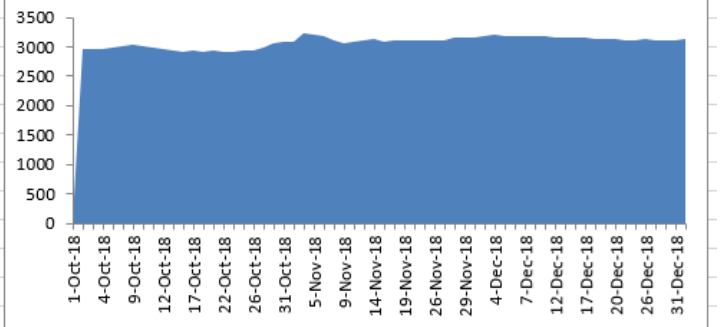
